

## Areas That Need Improvement

#### Conferences:

- More Technical Case Studies (O&M, etc.) Especially by Owners (50/50 Owner/Vendor)
- Increase Attendance and Involvement with CIBO by having Inactive Members Give Case Study Presentations

#### Committees

- Energy Committee
  - Needs More Focus on Current Issues With Natural Gas as Sole Source of Production
  - Emphasis on Conservation of Energy, Efficiency, and Alternate Sources (Especially Cutting Edge)
- Membership Committee Needs to Appeal to Other Non Power Producing Entities That Would Benefit From CIBO Experience
- Issue with CIBO Information Access and Availability
  - Need searchable on-line database of policy and guidance



#### Things Members Would Like To See

- Hold a "Train-The-Trainer" Meeting on Higher Logic Program so Members can Train Plant Site Personnel
- Broader Focus on Environmental Topics Impacting Turbines, IC Engines, and Other Combustion Equipment Located at Owners Site
- Develop Operations and Maintenance Areas to include all types of boilers and fuels
- Natural Gas combustion oriented issues and regulations, controls, efficiency, monitoring, operation
- Energy Committee Discussion on Energy Savings Associated with Asset Management
- Maybe Opportunity to Modify NSR if EPA Goes from Clean Power Plan to Unit Energy Efficiency to Reduce GHG
- Benchmarking and Environmental Management Systems
- More Direct Access to Resources (Congress/Sub Committees) That Can Affect the Laws to Improve Our Ability to See CAA and CWA Modifications That Are Industry Focused

  - Declining Installed Base of Solid Fuel Fired Boilers
  - Increase in Gas Fired Steam Generation Installations
  - Assumption by Some Owners That Gas Fired Units No Longer Require a High Level of Support or Services
  - Current Assumption That CIBO is Primarily Focused on Regulatory and Government Affairs and Related Issues, with Lesser Focus on Technical or Operational Functions

Given Above, CIBO Needs to Re-focus to Remain a Relevant and Viable Organization
