

 Allowance, Compliance, Facility/Unit Attributes & Emissions



#### **Bulk Data Files**

CAMPD provides access to larger bulk downloads of apportioned and raw emissions, allowance, and compliance data by maintaining access to static datasets available through EPA's FTP site. The FTP site is accessible here and has groupings of data which may be directly accessed using one of the links below.

#### **Emissions**

- · Apportioned Unit-Level Daily Emissions (updated quarterly)
- Apportioned Unit-Level Hourly Emissions (updated quarterly)
- · Apportioned Unit-Level MATS data (updated quarterly)
- Hourly Continuous Emissions Monitoring (CEM) data files formatted for use with the Sparse Matrix Operator Kernel Emissions (SMOKE) modeling system version 2.3 or later. (updated annually)

## When will CAMPD be available?

CAMPD is planning a late spring release (est. April 2022)

The old application (AMPD) will be available for a transition period upon CAMPD's release

The FTP site that serves the Bulk Data Files (aka prepackaged data) will be maintained
